A LOCAL LAW AMENDING TOWN OF GEDDES TOWN CODE §190 SUBDIVISION OF LAND,
AMENDING SECTION 190-1 ARTICLE 1 TERMINOLOGY §190-1. DEFINITIONS, BY REPLACING
THE DEFINITIONS OF "MAJOR SUBDIVISION" AND "MINOR SUBDIVISION" AND ADDING A
NEW "ARTICLE IV - SIMPLE SUBDIVISION"

BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF GEDDES AS FOLLOWS:

Section I: The Town of Geddes Town Code, being Local Law No.1 of 2001, as has previously been amended, is hereby further amended by striking therefrom the portion of Code §190-1. Definitions of "MAJOR SUBDIVISION" and "MINOR SUBDIVISION" and replacing them with a new definition entitled "SUBDIVISION" and adding a new ARTICLE IV – SIMPLE SUBDIVISION, respectively, as follows:

New §190-1. Definitions. To read as follows:

SUBDIVISION — A division of any part, parcel or area of land by the owner or agent either by lots or by metes and bounds into lots or parcels two or more in number for any purpose, including the purposes of conveyance, lease, transfer, improvement, building development or sale. The term "subdivision" includes resubdivision, which also includes consolidation of lots into a lesser number of lots or elimination of lot line(s).

A. SIMPLE SUBDIVISION — A division of land involving the adjustment of an existing lot line(s) without the creation of a new or an extended street(s), curb cuts, infrastructure or building lot(s); or the elimination of an existing lot line(s) so as to consolidate one or more lots into a lesser number

without the creation of a new or an extended street(s), curb cuts, infrastructure or building lot(s).

and

Adding a new "ARTICLE IV – SIMPLE SUBDIVISION" to read as follows:

§190-11. Simple Subdivision.

- A. Upon receipt of a request for a simple subdivision, as defined in §190-1, above, including a location survey plan map showing all buildings, easements, existing infrastructure, existing and proposed lot lines, as well as receipt of the fee therefor as specified by the Town Board, the Town Code Enforcement Officer shall review such request in order to determine whether the proposed simple subdivision plan map complies with all Town zoning and other laws, rules and regulations and that the subdivision will not affect neighboring properties so that a public hearing is not necessary and may be waived.
- B. In his/her sole discretion, the Town Code Enforcement Officer may refer any such request to the Planning Board for its advice and/or recommendation. The Planning Board shall have 30 days to respond to the Town Code Enforcement Officer
- C. In the event that the Town Code Enforcement Officer makes a determination that such subdivision plan map does not comply with all Town zoning and other laws, rules and regulations or will affect neighboring properties, the Code Enforcement Officer shall disapprove such request and advise of the nature of the defect or why the application must go through the normal subdivision process as stated in this Chapter 190.
- D. Upon approval of a simple subdivision, the Code Enforcement Officer shall endorse said map indicating his/her approval for filing in the County Clerk's office pursuant to the authority of this Code and the applicant shall provide such number and type of copies of the approved plan and any other information as the Code Enforcement Officer shall specify for the Town's records.

Section 2: Local law No.: 1 of 2001, as amended, remains in full force and effect except as hereinabove amended.

Section 3: This local law supersedes any provisions of Town Law Article 16 to the extent that this local law is inconsistent therewith, particularly §§ 276, 277 and 278 of the Town Law.

Section 4: This local law shall take effect immediately upon posting and publication as required by law and filing with the Secretary of State.
