- 6. Authorization from the Town Board for the Supervisor to execute a memorandum of understanding with the Town of Onondaga to share data collection.

- 7. Authorization from the Town Board for the Supervisor to sign an Energy Savings Plan with National Grid for the Highway Garage. The plan is an energy conservation program to certain commercial and industrial customers that have an average monthly demand less than or equal to 110 kW. Under the Program, the Company is arranging the installation of certain energy efficiency measures at the facilities of eligible customers. Estimated annual cost savings of \$4,282.06.
