- 3. Authorization from the Town Board to accept the letter of retirement of Geddes Police Sergeant Gail Barrella. Sgt. Barrella's retirement will be effective September 14<sup>th</sup>, 2018 after serving 32 years with the police department.
- 4. Authorization from the Town Board to approve the renewal of a 2-year warranty extension and service contracts with Dell for server hardware. Total cost is \$4200.

Authorization from the Town Board to schedule a public hearing on October 9<sup>th</sup>, 2018 at 7 p.m. to consider a Local Law amending Town of Geddes Town Code §190 Subdivision of Land, amending section 190-1 article 1 terminology §190-1. definitions, by replacing the definitions of "major subdivision" and "minor subdivision" and adding a new "article iv simple subdivision.
- 6. Authorization from the Town Board for the Supervisor to appoint Debbie Morrell a provisional status of the Director of Parks and Recreation. This exempt position will have a salary of \$48,150.00 and is effective September 11, 2018.
