- 6. Authorization from the Town Board for the engineer to advertise for bids for the Town Hall Atrium Wall repairs. The project is funded by a grant from DASNY.
- 7. Authorization from the Town Board to approve the Court Clerks (Barbara Lenweaver, Isabella Rogmans-Lenweaver, Megan Cavaliere) to attend the 2018 NYSAMCC Annual Fall Training Conference to be held from Sunday, September 16th Wednesday, September 19th, 2018 in Lake Placid, NY for a cost of \$1737.00 (hotel, meals, registration) plus mileage. These funds are available and budgeted for in the travel line.
- 8. Authorization from the Town Board to renew the agreement with Dannible and McKee for accounting services at a rate of \$5,800 per month (no increase over prior year) for the period of August 15, 2018 through August 14, 2019.

Authorization from the Town Board to call a public hearing to be held at the Special Town Board Meeting at the Town of Geddes Town Hall on August, 2018, at o'clockm. on a Local Law proposing to change the term of office of the Town Supervisor from two (2) years to (4) years and thereby superseding Town Law section 24 as it pertains to the term of office of the Town Supervisor. This proposed Local Law if adopted will be subject to mandatory referendum.
12.	Authorization from the Town Board to call a public hearing to be held at the Special Town Board Meeting at the Town of Geddes Town Hall on August, 2018, at o'clockm. on a Local Law proposing to change the term of office of the Town of Geddes

Highway Superintendent from two (2) years to (4) years and thereby superseding Town Law section 24 as it pertains to the term of office of the Town of Geddes Highway Superintendent.

This proposed Local Law if adopted will be subject to mandatory referendum.
