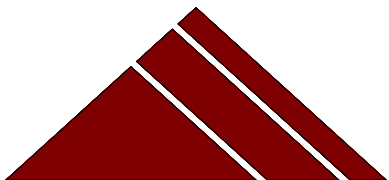

Minimum Control Measure 1: Public Education and Outreach

- The Town continues to contract with CNYRPDB to provide stormwater trainings, mailings, articles, and commercials.

Minimum Control Measure 2: Public Involvement/Participation

- The Annual Report and SWMP are on file with the Town Clerk and available for public review and comment.
- The 2019-2020 Report will be placed on the Town website for review by the public.
- The Town continues to support and promote the annual volunteer spring clean-up.
- No stormwater related comments were received by the Town during the reporting year.

Minimum Control Measure 3: Illicit Discharge Detection and Elimination

- The Town continues a debris management program, including yard waste pick-up, catch basin cleaning, and street sweeping.
- The Town maintains an agreement with Onondaga County to inspect outfalls. No outfalls were inspected this reporting period.
- The Town maintained a stormwater hotline for reporting illicit discharges and has a local stormwater contact to investigate any calls received. No illicit discharges were reported or investigated during this reporting period.

Minimum Control Measure 4: Construction Site Stormwater Runoff Control

- There are 4 active construction projects requiring SWPPP Permits and inspections, including 1 new approved project.

Minimum Control Measure 5: Post-Construction Stormwater Management

- Inspected 12 stormwater facilities including, no maintenance was required.
- Town will continue training on CIVICGOV records management system.

Minimum Control Measure 6: Pollution Prevention/Good Housekeeping for Municipal Operations

- The Town Department of Public Works:
 - Swept a total of 1,440 miles of streets, and 8 acres of parking lots.
 - Cleaned and inspected 196 catch basins.
 - Recycled oil through 3rd party vendor.
 - Collected and composted approximately 3,000 yards of yard waste.


